

Thank you for taking an interest in the financial health of The Foster Alliance (TFA), previously known as Arizona Helping Hands (AHH).

Since 1998, AHH has had a strong history of providing a broad range of services and since we narrowed our focus in 2014 to the foster care community, we have become the state's largest provider of essential services.

During FY 2024, as our organization continued to be mission-centric we celebrated being able to provide more services and geographic reach than in previous years. The infrastructure and program models developed over the past two years shaped our organization into a professional, innovative, and nimble human-centric entity. This year we were also able to increase our net assets while managing a balanced budget. Knowing investment in organizational operations remains a priority while providing additional mission-centric reach, TFA kept its operational and fundraising costs within the Better Business Bureau standards ending the year with 79% of TFA's resources invested in program costs.

Key partnerships with Native American Tribes and the Department of Child Safety (DCS) throughout the state of Arizona continued to be a priority. TFA was often showcased as a "go to" organization which produced record breaking program results – (unduplicated numbers noted below):

- Provided essential services to 8632 children experiencing foster care.
- Supported 5022 families who open their hearts and homes to children who need a place to call home.
- Distributed more than 942,580 items throughout the state of Arizona via two mobile units and a newly opened Flagstaff, AZ office. (FY23 total was 867,778).

TFA's mission is to support the foster care community by providing essentials to benefit children in foster care. Our full commitment is to provide our services in a safe, human-centric environment, where our broad community members (donors, volunteers, clients, and staff) can support families who open their hearts and homes to the more than 12,000 children in foster care. Our collaborative efforts throughout the State of Arizona are grounded in our why: we believe all kids deserve a chance to win!


